Participants Agreement, Release, and Acknowledgement of Risk in consideration of the Service of On Deck Baseball Training, their agents, owners, volunteers, officers, participants, contractors, and all other persons or entities acting in any capacity on their behalf. I hereby agree to release and discharge On Deck Baseball Training, on behalf of myself, my children, my parents, my heirs, assigns, personal representatives and estate as follows.

1. I acknowledge that baseball entails known and unanticipated risks which could result in physical or emotional injury, paralysis, death, or damage to myself, to property, or to third parties. I understand such risks simply cannot be eliminated without jeopardizing the essential qualities of the activity. Participants acknowledge that the risks involved but not limited to: being struck by a bat or ball, collisions with other players, or fences, sliding into bases, all that may result in contusions, sprains, fractures, broken bones, or concussions. Furthermore ODBT employees and contractors have difficult jobs to perform. They seek safety but they are not infallible. They might be ignorant to participant's fitness or abilities. They may give inadequate warnings or instructions and the equipment being used might malfunction.
2. I expressly agree and promise to accept and assume all of the risk existing in this activity. My participation in this activity is purely voluntary and I elect to participate in spite of the risks.
3. I hereby voluntarily release, forever discharge, and agree to indemnify and hold harmless ODBT from any and all claims, demands, or cause of actions, which are in any way connected with my participation in this activity or my use of ODBT equipment or facilities, including any such claims which allege negligent acts or omissions of ODBT.
4. Should ODBT or anyone acting on their behalf be required to incur attorney's fees and costs to enforce this agreement, I agree to indemnify and hold them harmless for all such fees and costs.
5. I certify that I have adequate insurance to cover an injury or damage I may cause or suffer while participating, or else I agree to bear the costs of such injury or damage to myself. I further certify that I have no medical or physical conditions, which could interfere with my safety in this activity, or else I am willing to assume and bear the costs of all risks that may be created, directly or indirectly by any such conditions.

By signing this document, I acknowledge that if anyone is hurt or property is damaged during my participation in this activity. I may be found by a court of law to have waived my rights to maintain a lawsuit against ODBT on the basis of any claim from which I have released them herein.
